संख्या एफ.30(8)आर.बी./2009/1777 .—In exercise of the powers conferred by clauses (r), (s), (u), (v) and (w) of section 13, section 30 and clause (h) of section 31 of the Dr. Sarvepalli Radhakrishnan Rajasthan Ayurved University Act, 2002, the Dr. S.R. Rajasthan Ayurved University hereby makes the following rules further to amend the Rajasthan Ayurved University Service Rules, 2009, namely:

- 1. Short title and commencement.- (1) These rules may be called the Rajasthan Ayurved University Service (Amendment) Rules, 2019.
- (2) They shall come into force with effect from the date of there publication in the Official Gazette.
- 2. Amendment of rule 1.- In sub-rule (1) of the Rajasthan Ayurved University Service Rules, 2009, hereinafter referred to as the said rules, for the existing expression "Rajasthan Ayurved University", the expression "Dr. Sarvepalli Radhakrishnan Rajasthan Ayurved University" shall be substituted.
- 3. Amendment of rule 2.- The existing rule 2 of the said rules, shall be substituted by the following, namely:-
- "2. Name of service.- Name of the service shall be the Dr. Sarvepalli Radhakrishnan Rajasthan Ayurved University Service."
- 4. Amendment of rule 4.- In rule 4 of the said rule for the existing expression "Rajasthan Ayurved University, Jodhpur", where ever occurring, the expression "Dr. Sarvepalli Radhakrishnan Rajasthan Ayurved University" shall be substituted.
- 5. Amendment of rule 25.- In rule 25 of the said rule after existing sub rule 3, the following new sub rule 4 and 5 shall be added, namely:-
 - "(4) The Annual performance appraisal reports and norms as prescribed by University, as amended from time to time, shall be applicable for promotion.
 - "(5) For recommendation for promotion the Vice-Chancellor shall constitute committee. The names of suitable candidates shall be recommended by the committee. After receipt of recommendation from the Promotion Committee final decision shall be taken by the Board of Management."

6. Amendment of SCHEDULE - I.- In schedule-I appended to the said rules the existing head (A) teaching (UG College) and entries relating there to shall be substituted by the following, namely:-
